ERA ANNOUNCES ENERGY EFFICIENCY MEASURES

The Electricity Regulatory Authority (ERA) announced the procurement and distribution of Light Emitting Diodes (LEDs) to electricity consumers as part of the Demand Side Management measures that will promote efficient consumption of energy.

The Demand Side Management measures are important for the management of peak demand to defer the need for additional generation capacity.

The announcement was made at a Press Briefing held on October 21, 2014 at ERA House, to share with the public the developments and future outlook of the

electricity industry.

ERA AT THE FUTURE OF CITIES FORUM 2014

The Electricity Regulatory Authority (ERA) on Thursday, October 2, 2014 took part in the Future of Cities Forum 2014. The Forum was hosted by Kampala Capital City Authority at the Speke Resort Munyonyo.

At the Forum, Eng. Ziria Tibalwa Waako, the Director Technical Regulation, ERA revealed the Authority's Demand Side Management (DSM) Plan that will address the challenge of increasing demand for energy in Uganda's urban areas.

The DSM Plan includes interventions such as promotion of efficient lighting technologies and

applying Time of Use (ToU) tariffs among others.

The Future of Cities Forum (FCF) is an annual, international urban development conference organized by the World Future Council. It is hosted on a revolving basis in different cities of the world; the 2014 edition is the first of its kind in the East African region. The major themes at this year's Forum were Powering our Cities; Planning our Cities; and Water and Sanitation.

POLYMER FILM STICKERS TO INCREASE POWER GENERATION



Polymer film stickers are one of the unique ways of making solar panels more efficient in power generation. The Polymer film sticker is a large transparent sticker applied to the front of the panel which increases the power output by about 10% or so.

These stickers are imprinted with special kind of microstructures that are capable of bending, redirecting and absorbing more sunlight so that more power is generated.

Even the solar panels that are operational can have these polymer stickers easily applied to them and the stickers will boost their efficiency.


LASTLY..... JUST MARRIED
